SCHOOL BOARD REORGANIZATION MEETING

December 6, 2004

MINUTES

1. **CALL TO ORDER** - Mr. Dean Berkebile, Board President, called the meeting to order at 8:00 p.m.
 - A. **Moment of Silence** - The moment of silence was in remembrance of Alex Poust, an 8th grade student, and William Waldren, a former principal, who passed away.
 - B. **Pledge of Allegiance** - Mr. Berkebile led the Pledge of Allegiance to the Flag.
 - C. **Roll Call** - Roll call by Joan Rinaman, Board Secretary, showed the following Board members present: Mr. Paul Adametz, Mr. Dean Berkebile, Mr. Kenneth Brennan, Mr. Anthony Evans, Mr. Robert Hill, Jr., Mr. William Paul, Mrs. Ann Reale, Mr. Anthony Storti, and Mr. Jeffrey Widdowson.

Others present included Dr. Donald Tylinski, Superintendent; Dr. Denise Chappell, Assistant Superintendent Secondary; Dr. Mary Ann Marchi, Assistant Superintendent Elementary; Mr. Lynn Stewart, Administrative Assistant for Financial Affairs; Mr. Jerome Straughter, Human Resources Director; Mrs. Linda Andreassi, Public Relations Coordinator; Mr. Matthew Hoffman, Solicitor; visitors on list; and press representatives.

2. **PUBLIC COMMENT** - There were no public comments on the reorganization.
3. **ELECTION OF A TEMPORARY PRESIDENT** of the Reorganization Meeting. Mr. Hill motioned, seconded by Mr. Storti, to nominate Mr. Paul as temporary president. Motion carried unanimously on a voice vote.
4. **PRESIDENT AND VICE-PRESIDENTIAL ELECTIONS** - Mr. Paul asked for nominations for the offices of President and Vice President of the Board.

Mr. Hill nominated Mr. Berkebile as President. There were no other nominations and the motion carried unanimously on a voice vote.

Mrs. Reale nominated Mr. Hill as Vice President, followed by Mr. Widdowson nominating Mr. Evans, and Mr. Adametz nominating Mr. Brennan. The votes tallied as follows: Mr. Evans, Mr. Paul, Mr. Storti, Mr. Widdowson, and Mr. Berkebile voted for Mr. Evans; Mr. Hill, and Mrs. Reale voted for Mr. Hill; and Mr. Adametz, and Mr. Brennan voted for Mr. Brennan. Mr. Evans was declared the new Vice President with five votes.

5. **ADJOURNMENT** - Mr. Hill motioned, seconded by Mr. Adametz, to adjourn the meeting at 8:07 p.m. Motion carried on a voice vote with those present voting in the affirmative. The meeting adjourned to the special meeting.
