SCHOOL BOARD REORGANIZATION MEETING

Seneca Valley Intermediate High School Auditorium

Minutes

December 12, 2005

1. **CALL TO ORDER** - Mr. Paul, temporary president, called the meeting to order at 8:00 p.m.
 - A. Moment of Silence - The meeting was opened with a moment of silence.
 - B. Pledge of Allegiance - Mr. Paul led the Pledge of Allegiance to the Flag.
 - C. Roll Call - Roll call by Joan Rinaman, Board Secretary, showed the following Board members present: Mr. Paul Adametz, Mr. Dean Berkebile, Mr. Kenneth Brennan, Mr. Anthony Evans, Mr. Robert Hill, Jr., Mr. William Paul, Mr. Thomas Roth, Mr. Anthony Storti, and Mr. Jeffrey Widdowson.

Others present included Dr. Mary Ann Marchi, Assistant Superintendent for Human Resources and Pupil Services; Dr. Matthew McKinley, Assistant Superintendent Secondary; Mr. Lynn Stewart, Business Manager; Mrs. Linda Andreassi, Communications Director; and visitors listed on the enclosed list.
2. **PUBLIC COMMENT** - There were no public comments.
3. **OATH OF OFFICE** - It was not necessary to administer the oath of office to Mr. Evans as he completed this with the magistrate.
4. **ELECTION OF OFFICERS** - Mr. Paul asked for nominations for Board President. Mr. Hill nominated Mr. Berkebile and Mr. Adametz nominated Mr. Brennan. Mr. Hill motioned, seconded by Mr. Adametz to close nominations. Motion carried on a voice vote with those present voting in the affirmative. Mr. Berkebile was elected President with Mr. Roth, Mr. Storti, Mr. Brennan, and Mr. Adametz voting for Mr. Brennan, and Mr. Widdowson, Mr. Paul, Mr. Hill, Mr. Evans, and Mr. Berkebile voting for Mr. Berkebile.

Mr. Widdowson nominated Mr. Hill, Mr. Adametz nominated Mr. Brennan, and Mr. Evans nominated Mr. Storti for Vice President. Mr. Widdowson motioned, seconded by Mr. Storti, to close the nominations. Motion carried on a voice vote with those present voting in the affirmative. Mr. Hill was elected Vice President with Mr. Widdowson, Mr. Hill, Mr. Paul, Mr. Evans, and Mr. Berkebile voting for Mr. Hill; Mr. Adametz, Mr. Brennan, and Mr. Roth voting for Mr. Brennan; and Mr. Storti voting for Mr. Storti.

- A. **Board Committee Assignments** - Mr. Berkebile asked Board members to review the committee list and indicate which they would like to serve on. Mr. Berkebile will make assignments at the January meeting.
- B. **Classroom Parties** - Dr. Marchi informed the Board that the buildings will be having classroom and PTA parties.

6. **ADJOURNMENT** - With nothing further to come before the Board, Mr. Hill motioned, seconded by Mr. Storti, to adjourn the meeting at 8:20 p.m. Motion carried on a voice vote with those present voting in the affirmative.
